General Information about the Board of Directors

The Board of Directors of Pregnancy Services of Delta County (PSDC) is made up of 7 members. There are six elected members--each serving a three year term with two of the six having their term beginning in January of any given year. The Executive Director manages the day to day operations of the organization as a paid employee; the Executive Director is also a standing member of the Board.

The Board of Director meetings are held once a month on a date and time set by the majority of the Board (currently, the 2nd Tuesday of each month from 4 to 5:30 pm). In addition to regular meetings, Board members are asked to attend and solicit contributions for fundraising events. They are also asked to take part in staff enrichment activities (i.e. gatherings designed to promote camaraderie and communication, retreats, trainings, etc). Individual Board members will at times be called upon to use their specific skill set or talents as the need arises. Members can anticipate 3 or 4 extra activities or meetings each year in addition to the monthly Board meetings.

Board members are also asked to be willing to hold an office (ie, President, Vice President, Treasurer, or Secretary). These offices are held for a period of one year. At that time another election is held and any Board member may be nominated.

Additionally, Board members are strongly encouraged to become regular donors to Pregnancy Services of Delta County. This may be done through our auto-pay donation program.
